**PA WORKERS' COMPENSATION CHECKLIST**  
**(some of the more common procedural issues)**

- **Notice of New Claim:**
  - Denial or Acceptance filed within 21 days?
- **Temporary Liability Accepted:**
  - File diaried for 90 day deadline?
- **Permanent / Serious Injuries:**
  - File diaried for Impairment Rating at 104 weeks of TTD?
- **Pre-Authorization Request** of health care provider:
  - Pre-authorization given, or
  - Denied as unrelated, or
  - Submitted to prospective Utilization Review?
- **Medical Release to Return to Work:**
  - Notice of Ability to Return to Work mailed?
  - Employer modified / regular duty job offer?
  - Assignment to vocational expert for Earning Power Assessment?
- **Medical Finding of Full Recovery:**
  - Termination Petition filed by defense counsel?
- **Claimant's Return to Work:**
  - Notification of Suspension / Modification filed within 7 days? *If not,*
  - Supplemental Agreement signed and filed?  
*If not,*
  - Suspension Petition filed by defense counsel?
- **Petition Filed by Claimant**
  - Answer filed by defense counsel within 20 days of Notice of Assignment?
